

DEFINITION OF AN ELIGIBLE EMERGENCY

Flying Doctors Medical Personnel will be responsible for the decision as to whether the condition and location of the member warrant a free evacuation flight. If applicable, and where possible, the member may be requested to be seen by a medical person before a free evacuation is granted. The Flying Doctors reserve the right to charge a member in full for the evacuation should they discover that any medical condition has been fraudulent, intentionally exaggerated or if fraudulent means or devices have been used by the member, or anyone acting on your or their behalf in order to obtain a free evacuation flight.

EMERGENCIES

Includes but not limited to:

Shock, Coma, Burns, Respiratory Emergencies, Cardiovascular Emergencies, Snake Bite,

Animal Bite, and Other Tropical Diseases, Hyperbaric Emergencies, Psychiatric Emergencies, Surgical Emergencies, Major Trauma Obs/Gynae Emergencies, Pediatric Emergencies and many more

EXCLUSIONS

Free evacuations will not be granted in cases such as the following:

1.The patient is not suffering from an immediately life-threatening medical condition and/or:

2. The condition can be treated at a medical facility near to the patient's location

3.The patient's condition is not serious enough to warrant air ambulance evacuation, and the patient can be transported by an alternative means such as by road to the nearest medical facility.

4.The patient's emergency has arisen as a result of self-inflicted damage or injury, such as attempted suicide, active involvement in violent or war-related activities, alcohol or drug abuse.

THE COMPANY'S OBLIGATIONS

1.The Company will provide FDSA with an updated list of clients to be covered for evacuation services.

2. The Company must ensure that the members are issued with his/her membership numbers.

3.The company must ensure that the members are made aware of our terms and conditions including exclusions as outlined above

4.Members should be advised to know their membership number at all times during membership period.

5.FDSA MUST be notified of members details to be covered prior to commencement of membership. This information should be sent to;
